## MEET OUR 2024 PROGRAM CHAIR AND PROGRAM CHAIR ELECT!

**Cyril Ghosh**, NPSA's current Program Chair and Vice-President, was presented at our 2004 conference as graduate student! Since then, and over the last two decades, Cyril has participated at NPSA in many different capacities. He is also closely associated – both personally and professionally – with several members of the current and past Executive Boards. In 2023, Program Chair (and now President) Yunus Sozen invited Cyril to take on the role of Program Chair this year – an invitation Cyril enthusiastically accepted!



Cyril is Associate Professor and Lloyd B. Politsch '33 Chair of Law at Clark University. He is the author, among other things, of *The Politics of the American Dream: Democratic Inclusion in Contemporary American Political Culture* (Palgrave-Macmillan, 2013), *De-Moralizing Gay Rights: Some Queer Remarks on LGBT+ Rights Politics in the US* (Palgrave-Pivot, 2018), and *Key Concepts in Political Theory: Citizenship* (with Elizabeth F. Cohen; Polity, 2019). Cyril teaches courses on constitutional law, American politics, citizenship & immigration, and gender & sexuality. He researches topics relate to queer theory, public law and sexuality, citizenship & immigration, and the American dream as ideology. His article, "Dancing Around Gender Expression & Sex Talk: LGBTQ+ Asylum Policy in the US," was published earlier this year in the *Journal of Human Rights*. Cyril has a B.A. (1998) in political science and an M.A. (2000) in international relations from Jadavpur University, India; an M.A. (2005) and Ph.D. (2008) from Syracuse University, New York; and M.P.A. (2017) from New York University.

**Ian J. Drake**, who was recently appointed NPSA's Second-Vice-President & Program Chair-Elect, is Associate Professor of political science and law at Montclair State University. He previously practiced law and earned a PhD in US history from the University of Maryland. He has expertise in the areas of United States Constitutional law and history, the history of tort law, political theory, and animal rights law and policy. He has an abiding interest in the intersection between popular culture and political theory, especially how political thought can inform our interpretation of popular art and drama.



Some of Ian's recent publications include a book chapter co-authored with Matthew B. Lloyd, entitled "You Can't Fight City Hall!" in Batman's Villains and Villainesses: Multidisciplinary Perspectives on Arkham's Souls. Justin Martin and Marco Favaro, Eds. (Lexington Books / Rowman & Littlefield: 2023), and "Free Speech Rights v. Property and Privacy Rights: 'Ag-gag' Laws and the Limits of Property Rights," Independent Review Vol. 25, No. 4 (Spring 2021). He first got involved with NPSA when a colleague suggested presenting a draft paper at the conference.
